### **1. DESCRIPTION**

The DotSCOT Registry CIVIC SCOTLAND reserved list of names (see Appendix 1) will be released for registration on January 20th 2015, 13:00 UTC.

CIVIC SCOTLAND reserved list is being released by the dotSCOT Registry in order to allow registrations from entities, public or private, with a specific right to register the names contained in the Appendix 1.

Names contained in the CIVIC SCOTLAND reserved list will stay blocked until the DotSCOT Registry validates the rights of each individual registration. This Registry validation will be carried out in a weekly basis.

### **2. ELIGIBILITY AND NAME SELECTION**

Domain names included in the Appendix 1 may only be registered by those entities that are unequivocally associated with such name.

The names contained in the Appendix 1 can be categorised according to the following structure:



- Names with a geographic scope within Scotland: domain names that are associated with any administrative entity or relevant landmark in Scotland.
- Names with a connection to Government Organisations: domain names that are associated with a Government Organisation as defined by the Government of Scotland.
- Names with a connection to a Public Service: domain names that are associated with activities conducted in connection with a public service, by either a Public Administration or a private entity in partnership with a Scottish Public Administration.

### **3. VALIDATION**

Registrations of the names contained in the CIVIC SCOTLAND reserved list of names are subject to a post-registration validation by the Registry.

Domain names contained in this list have no functioning services associated with them (web content, email, etc) until the Registry considers the registration as valid.

The DotSCOT Registry will validate registrations of the CIVIC SCOTLAND reserved list of names in a weekly basis. Registry may request registrants to provide more information if needed in order to validate the registrations.

Registry will remove any usage restrictions to valid registrants and will cancel not compliant registrants with no refund.

### **4. PRICE**

Initial registration of the names contained in the Appendix 1 is set at 150 GBP. Additional years and renewals will be charged at the regular renewal price.

### **5. DURATION**

The CIVIC SCOTLAND phase will start on January 20th 2015 13:00 UTC and will end on July 20th 2015 13:00 UTC.
